## MOTORIZED VEHICLE USAGE FORM

Driving to school is a privilege, students who drive to school agree to the following rules regarding motorized vehicle usage.

- Students must purchase a parking permit from the office to park in the student lot. Permits cost \$10.00 per school year.
- Students must also complete a vehicle registration form. (see back of this form)
- A parent and the student must sign this usage form to receive a permit.
- All vehicles are to be parked in an orderly fashion in the spaces provided.
- Designated student parking is in the large lot south of the High School between Kehoe Road and the high school.
- Clinton Community Schools personnel reserve the right to search any vehicle driven by a student. A search of a vehicle driven by a student may be conducted at any time the student is under the jurisdiction of the Board of Education.
- Upon arrival at the high school, the vehicle is to be immediately parked in the student parking lot. Students are prohibited from parking in the teachers' parking lot, on the lawn, on the sidewalks, in the driveway, or aisle property. Automobiles which are not properly parked will be subject to one or all of the following warning, parking ticket (\$5.00), loss of driving privileges, or disciplinary action by the school.
- Students are to immediately vacate the vehicle and at **no** time during the school day are students to be in or around the cars in the student parking lot without permission from the Principal or office personnel.
- At **no** time is a student of CHS permitted to **drive**, **ride**, **or be in** a vehicle during the school day without parental and Principal approval. Violation of this regulation will result in an in-school or out-of-school suspension to be determined by the Principal. Students are not permitted to drive or ride to the Vo-Tech Center. Bus transportation is provided.
- Students are not permitted to **drive**, **ride or be in** a vehicle during the lunch period.
- **The speed limit is 15 miles per hour.** Reckless, dangerous, or unsafe driving is prohibited and will result in the loss of parking privileges.
- Driving to school is a privilege which may be suspended or revoked with cause at any time. Violators are also subject to ticketing for violations on school property.

I have read the rules above regarding use of motorized vehicles and I agree to follow them. I understand that if the rules stated above are not followed that driving privileges can be revoked and further disciplinary action can be taken by school administration.
